## They can't fool us!

### DUTRA'S RECORD:

*Dutra cannot be trusted to comply with the FEIR's 140 mitigations to keep us safe. And we can't afford to watch them. Their national record of violations, fines, and a Marin County Grand Jury investigation tell us that they are not a "good neighbor."*

- **In Petaluma, Dutra's temporary asphalt batch plant operation was shut down by BAAQMD** for operating without a permit, and failure to use Best Available Control Technology.

**Asphalt recycling and production is a dirty, smelly, noisy, toxic industrial process**, best located far from homes and schools. It will ruin the Shollenberger Park experience for 150,000 visitors a year who birdwatch, walk, and enjoy the wetlands and wildlife.
